This guide is not a general guide to treaty research. It is focused on specialized sources, particularly those dealing with environmental law. The first part lists regional treaty collections; the second part lists collections of environmental treaties; and the third part lists secretariats of environmental treaties that are not part of an intergovernmental organization.
